Summer Aid Information Sheet

The Financial Aid staff is here to help you address your Summer 2024 aid needs. Below is important information regarding financial aid for the Summer 2024 semester. Please review all the information below so you are well informed as a summer financial aid recipient.

**Process:**

- Complete a 2024-2025 FAFSA online.

You must have a 2024-2025 Free Application for Federal Student Aid (FAFSA) on file prior to applying for Summer 2024 financial aid. If you have not done this, please go to [studentaid.gov](https://studentaid.gov) and submit your FAFSA now.

***We will return all forms that are submitted without a 2024-25 FAFSA on file. You can check your FAFSA status on My Sage Aid. If we have one on file for you it will appear on your checklist as completed.***

- Register for Summer 2024 classes. Submit your form **AFTER** you have registered for your summer classes. If you are not registered at least ½ time, we will send the form back to you until you adjust your registration.
- In order to **receive your financial aid package before the tuition due date (May 1, 2024)**, you must **submit** your summer intent application **by April 12, 2024**. The deadline to turn in a summer intent form to receive aid for Summer 2023 is **June 14, 2024**. Applications will be accepted starting March 25, 2024 through June 14, 2024. Applications can be submitted in person, by mail or by email ([finaid@sage.edu](mailto:finaid@sage.edu))
- If you are eligible for aid, the Financial Aid Office will put together your financial aid package and notify you that your offer letter has been updated on your *My Sage Aid* account. *My Sage Aid* can be found under the Financial Aid section of Sage Self-Service. Review your online financial aid package and accept or decline any financial aid awards you are offered.
- If you are awarded a Stafford Loan and you are a first-time borrower at Russell Sage College, you must complete a **Direct Loan Master Promissory Note** and **Direct Loan Entrance Counseling Interview**. Both can be completed at [www.studentaid.gov](https://www.studentaid.gov).

## Summer Aid Information:

- Students must meet all Satisfactory Academic Progress (SAP) requirements to receive summer aid. SAP is not reviewed until after Spring 2024 grades are posted in May so it may be possible for someone to receive a financial aid award notice for Summer 2024 prior to May, only to have it revoked after SAP is reviewed. If you are unsure of your SAP status based on your anticipated Spring 2024 performance, please consult with a financial aid advisor. - Third Year DPT students that will be graduating in December 2024 will receive all financial aid for the summer semester. Some aid could be prorated based on the cost of tuition.
- Students must be accepted into an approved program of study and enrolled at least half-time. For financial aid purposes, half-time status for undergraduate students is 6 credit hours and graduate students is 4.5 credit hours. All credit hours taken throughout the summer sessions are combined to determine a student's overall summer term enrollment status for financial aid.
- *If your financial aid application was selected for verification, you must complete the verification process to receive a financial aid award package. **Please note that verification must be completed prior to May 24, 2024, to receive financial aid for the summer semester.***
- If you drop below half-time status before loan proceeds are disbursed, and you have failed to establish eligibility for the loan, the entire amount of the loan must be returned to the loan servicer.
- If you withdraw from your classes, stop attending without formally withdrawing, or never attend your classes, you may be subject to having all or a portion of your aid returned. This may result in a balance due and require immediate payment to Student Accounts. If you receive a refund you may be required to repay all or a portion of your summer refund check(s).
- **Book money is not available for the summer semester so please plan accordingly.**
- The final date that summer aid applications will be processed will be **June 14, 2024**.

**Affirmation:** I understand if I submit this form without having a 2024-25 FAFSA on file and/or without being registered at least half-time, my form will be returned to me and I will have to submit a new Summer Intent form once I meet all of the conditions listed above and before financial aid will be offered to me for the Summer 2024 semester.

### **\*\*\*IMPORTANT INFORMATION REGARDING SUMMER LOAN DISBURSEMENTS\*\*\***

*Due to the delay in the release of the 2024-25 FAFSA, summer loan disbursements **WILL BE DELAYED!** This means that if you are anticipating a refund, this will also be delayed. The Common Origination and Disbursement system (COD) which is used to process loans will not be available until sometime in May. We hope to be able to process loans by the end of May 2024 with refunds being issued by the second week of June. This date is subject to change depending on the availability of COD.*
