

## **Citizenship Status Confirmation Form**

## **Instructions**

The U.S. Department of Homeland Security-United States Citizenship and Immigration Services could not confirm that you are a U.S. citizen or non-citizen that is eligible to receive federal financial assistance. The U.S. Department of Education now requires all students to submit original documentation to confirm citizenship.

You must provide the Financial Aid Office with an original document of your U.S. citizenship or non-citizen eligibility. A comprehensive list of acceptable documentation is listed on the next page.

We understand that submitting an original document or proof of non-citizen eligibility to the institution may not be easily accessible in person. If you cannot present the original document in person to Russell Sage College, you may bring the original document along with a government issued photo ID to a public notary for completion. Once the form and documents are notarized, you can submit the notarized certificate of acknowledgment, notarized copy of the original document, and notarized copy of the government-issued photo ID to the Financial Aid Office.

If the Financial Aid Office suspects that the copied document(s) submitted are fraudulent or counterfeit, it may require the student to provide a true copy as certified by the issuing authority.
